

Parent's Pledge of Acceptance

- 1. We do hereby state that we have made a thorough investigation of the School's Student Handbook, curriculum, statement of faith, texts, methods, discipline, and motives of the School and do pledge to make them our positive choice for the coming School year.
- 2. We pledge that, if for any reason, our child does not respond favorably to the School, we will not try to fit the School to his needs but withdraw quietly and without delay.
- 3. We will pray for the School and as we are able we will use our time, talents, and gifts to benefit the School.
- 4. We hereby invest authority in the School to discipline our child as necessary, but we understand that the School does not use corporal punishment. We further agree that we will cooperate and discipline our child in the home as needed. (Proverbs 22:6, 29:15, 17; Colossians 3:20)
- 5. We understand that assessments will be made to cover any damage by our child to school property (including breakage of windows, abuse of books and equipment, etc.).
- 6. We agree to make monthly or semester tuition payments and to conclude all required payments on or before the last day of School of the applicable School year. We understand that the School reserves the right to dismiss any child whose financial obligations remain unpaid. We understand that reports and transcripts will be withheld if required payments are not made in full.
- 7. We hereby give permission for our child to receive individual achievement tests which will be administered by professional staff of the School.
- 8. We hereby give permission for our child to receive individual state-mandated medical screenings.
- 9. In order to prevent having illegal drugs at School, we give permission for our child to participate in drug screening tests as deemed necessary by the School administrator (**secondary only**).
- 10. We hereby give permission for the School teachers and administrators to approve <u>emergency</u> medical treatment for our child in the event we cannot be reached in a timely fashion under the circumstances.
- 11. We hereby give permission for our child to participate in all field trips, School activities, and sporting events, and absolve the School from any liability for injury to my child during School activities.
- 12. Parent(s) hereby grant an irrevocable worldwide, royalty-free right, and license to the School to utilize, adapt, modify, reproduce, distribute, publicly perform, and display photographs, video, or sound recordings of the Student during School events (collectively, the "Media"), including Student's image, likeness, appearance, and voice (collectively, "Likeness"), for use in legitimate and School-related promotional, educational, informational, advertising or commercial materials, and communications in any form now known or later developed, including publications, brochures, direct mail, websites, articles, newsletters, videos, and social media (collectively, the "Materials"). Parent(s) hereby waive any right to be notified or to inspect or approve the Media or any Materials that are created using Student's Likeness, now or in the future, whether that use is known or unknown to you. You hereby waive any right, now or in the future, to royalties or other compensation arising from or related to the use of the Media Materials for Student's Likeness.
