- Provide direct patient care
- Communicate with teachers, staff, parents/guardians, students and doctors
- Maintain confidentiality when handling health records and the privacy of students when in the clinic
- Administer medications as needed
- Chart and accurately document every clinic visit
- Notify parents when a student has been injured, receives medication or is ill
- Assist with managing all emergency medical conditions
- Assist with managing all chronic and/or complex medical conditions.
- Assist with checking and maintain all AEDs on campus, if requested
- Assist with medically related seminars, clinics, etc., if requested
- Assess medical release forms and alert appropriate staff of students with medical conditions, as needed
- Staying current with best practices and laws within the nursing profession
- Assist with maintaining an umbrella of authority from local physicians
- Perform and assist in any other duties assigned by Head of School

#### **Minimum Requirements:**

- Degree in Nursing
- Qualified to practice as a Registered Nurse in the state of Texas
- Certified CPR/First Aide

#### **Physical Requirements:**
